



## Standard Rules

Unless otherwise acknowledged, these rules apply to all promotions broadcast or operation by Forever Media, Inc. or any station they represent varied only as circumstances may require. All participants must agree to abide by these rules. The submission of an entry shall be deemed to indicate acceptance of these rules.

- ✓ Promotions are not open to employees or members of their immediate families (including spouse, parents, grandparents, children, brothers, sisters, aunts, uncles, and cousins and in any event the decision of Forever Media, Inc. shall be final and legally binding.
- ✓ Our promotions are intended to be fun without the intention of creating legal relations. Entry does not create an enforceable contract.
- ✓ Unless otherwise stated, no purchase or payment of any kind is required.
- ✓ Entries must be received by the radio station before the closing date and/or time subject to the absolute discretion of Forever Broadcasting, Inc.
- ✓ Where the prize may be won by a numbered caller or participant, the selection of the winning entrant will be at Forever Media, Inc.'s sole discretion.
- ✓ Forever Media, Inc. cannot be held responsible for any difficulty in communication with the radio station by telephone or other means.
